(a) *Heavy Vehicle Restrictions*

Heavy vehicle movements through the Willawarrin school zone are restricted to outside the peak school times of 8:00am to 9.00am and 2.45pm to 3.30pm on school days and that signage be erected at the exit point of the development site to reflect this information and the speed limits for the area for the information for truck drivers and other staff.

(b) *Code of Conduct*

A Code of Conduct is to be prepared and implemented and a copy given to Council on completion in pursuant of cl 16(1) (c) of the State Environmental Planning Policy (Mining, Petroleum Production and Extractive Industries) 2007, clearly detailing the following:

- *Vehicle speed through the town of Willawarrin;*
- *Times of school zone restrictions;*
- *Appropriate driver behaviour in relation to the current road rules;*
- *Vehicle description and registration details; and*
- *Driver details.*

The Code of Conduct is to be available on request at any time by Council staff.

It is noted that further noise reports may be required in the event of a complaint received either by Council or by DECCW.”
